New Features and Changes

COM-API

- Logging of rejected calls: When a COM call to Visum is rejected, the cause is now output to the log file to make troubleshooting easier. (23195)
- Output of notes in case of rejected COM calls: If the Visum COM server is busy, it can generally happen that incoming COM calls are rejected (exception 'RPC_E_SERVERCALL_RETRYLATER' (0x8001010A)). In this case, a note on possible causes is now output to the log file to facilitate the search for possible causes. (23085)

I/O Interfaces

- Acceleration of the PuT Updater: A moderate acceleration was achieved in the PuT Updater (Import 'PuT supply from Visum'). (23172)
- ♣ Error messages when accessing PTV Visum Publisher: The error messages issued when accessing PTV Visum Publisher have been made more specific and are now also written to the log file to make them more transparent. (23129)

PuT Assignment

Headway-based Assignment: The simultaneous headway-based assignment of many demand segments has been accelerated. (22693)

Visum Files

• Error message when reading corrupt Visum files: For all version files written with PTV Visum 21 or newer, errors in the file that occurred after the version file was written (e.g. during storage or transfer) are reliably detected. The error message issued in this case has now been significantly improved. In particular, the section of the version file affected by the data error is also mentioned. (23039)

Fixed Bugs

Add-Ins

Error when using weighted aggregation in 'Calculate Matrix': Using the weighted aggregation (function 'AVGW') in the 'Calculate Matrix' add-in resulted in an error message. This error has been fixed. (23082)

COM-API

Unspecific error message when using SaveVersion with an invalid path: Attempting to save a version file using SaveVersion in an invalid path previously resulted in the unspecific error message 'A serious error (Code e06d7363) has occurred in the script'. This message has been improved. (23200)

Data Model

Attributes of structural properties inaccessible for Tour-based model: The attributes of the network object structural property were only accessible with the add-on module EVA, although they are also required in demand models of type Tour-based model. This error has been fixed. (23055)

Formulas

Crash when accessing demand segments whose volumes are stored at other demand segments: If it was indicated in the general procedure settings for a PuT demand segment that the volumes would be stored at another demand segment, Visum crashed until now, if either a demand matrix correction was executed for this demand segment or the assignment matrix was accessed via a formula. This error has been fixed. (23104)

Error in MIRROR_LOWER function inside formula matrices: The MIRROR_LOWER function available in formula matrices returned incorrect results under certain conditions. This bug has been fixed. (23070)

I/O Interfaces

- Creating user-defined attributes in railML import parameter dialog resets entries: Entries made in the 'RailML import' dialog on the 'Attributes for timetable data' tab in the upper area for flagging imported vehicle journeys were reset when the 'Create user-defined attributes' button was pressed. This error has been fixed. (20781)
- Infinite loop during railML import: An infinite loop no longer occurs during simultaneous import of vehicle journeys and line blocks from railML in certain cases. (23163)
- Trajectory export to PTV Visum Publisher: When exporting trajectories to PTV Visum Publisher, incorrect data could occur. This error has been fixed. (22911)
- Warning for unlisted OCPs during railML import: If OperationControlPoints (OCPs) were used in trainPart elements while importing railML that are not listed in the infrastructure, this violation of the referential integrity of the railML file was previously accepted silently. Now such files can still be read in, but a warning lists all affected OCPs. (23058)
- Windows for login and Visum Publisher export sometimes in the background: On certain systems, it could happen that the window for login as well as the window for export to PTV Visum Publisher was not displayed as part of Visum but as a separate window in the Windows taskbar and could also be hidden by the main window of Visum. This error has been fixed. (22998)

Lists

- Analysis rows in path lists when switching the demand segment: After switching the displayed demand segments of a path list, the analysis rows (Min, Max, Sum or Avg) continued to display values matching the previously displayed content of the list. This error has been fixed. (23030)
- Marking when releasing the mouse outside the cells: If the mouse is released outside the display area of the cells when marking a whole block in a list or in the matrix editor, the marking displayed as a preview was not applied. This bug has been fixed. (22775)
- Missing update of the procedure variables list: If you changed the value of a displayed procedure variable in the 'Procedure variables - Values' list, the list continued to show the previous value. This error has been fixed. It was a mere display problem, internally the entered value was already effective. (22933)

Matrix Editor

- Calculation operations affected all matrices: If a matrix editor displayed several matrices and the tool window 'Matrices' was visible at the same time, a calculation operation (e.g. Set value) triggered in the shortcut menu of a matrix affected all matrices displayed in the matrix editor. This bug has been fixed. (22988)
- Marking when releasing the mouse outside the cells: If the mouse is released outside the display area of the cells when marking a whole block in a list or in the matrix editor, the marking displayed as a preview was not applied. This bug has been fixed. (22775)

Matrix Estimation

Crash when accessing demand segments whose volumes are stored at other demand segments: If it was indicated in the general procedure settings for a PuT demand segment that the volumes would be stored at another demand segment, Visum crashed until now, if either a demand matrix correction was executed for this demand segment or the assignment matrix was accessed via a formula. This error has been fixed. (23104)

Miscellaneous

- Cancel when license is lost reacts very slowly: If 'Cancel' was pressed in the dialog indicating the loss of the connection to the license in use, it took too long for the program to respond in a way visible to the user. This bug has been fixed. (22965)
- Visum terminates after loss of license: If several instances of PTV Visum were started and the connection to the license server was lost, one of these instances was sometimes terminated without further interaction as soon as the connection to the license server was restored. This error has been fixed. (23189)

Network Comparisons

No display of differences between POIs and user-defined tables: When comparing the current network to a version file, the values of both networks are displayed. However, this did not work for the values of user-defined attributes at POI categories or user-defined tables. This bug has been fixed. (23119)

Network Editor

Network section incorrect when marking ABM objects without a location reference: When marking an ABM object without a location reference, e.g. a newly inserted trip, the network editor showed the area around the coordinate (0, 0) when the synchronization mode 'Move' or 'Autozoom' was switched on. This error has been fixed. (23020)

Other Procedures

Negative buffer size possible in 'Intersect' dialog: In the parameter dialog of the 'Intersect' procedure, negative values could be entered for the buffer size of the source or target object, which were then treated as 0 during the actual calculation. This error has been fixed. (23025)

Passenger Surveys

Change between vehicle journeys on the same time profile always implausible: If in multi-line survey data specific vehicle journeys were indicated by their number and a change from one vehicle journey to another vehicle journey on the same time profile was required within a path, this path was always marked as implausible. This error has been fixed. (23038)

PrT Assignment

Merge weights did not always work in SBA: In the simulation-based dynamic assignment (SBA), merge weights did not always work correctly. This affected in particular one-lane ramps to multi-lane highways with left-hand traffic. This error has been fixed. (23179)

Procedure Sequence

Marking in procedure sequence extremely slow: Marking rows (=procedures) in the procedure sequence was unreasonably slow. This was especially noticeable when (accidentally) selecting all rows of a longer procedure sequence by clicking in the upper left cell. This error has been fixed. (22932)

PuT Assignment

- Connection file import and network changes: The program no longer crashes when carrying out a timetable-based assignment using percentage shares (MPA) and based on a connection file if, between writing this connection file and using it as the basis for the assignment, the network has been changed so that previously connected zones are no longer connected. In this case, the use of the connection file is now rejected. (23064)
- Crash in the transfers list after delay analysis: Crashes no longer occur in the display of the transfers list if a timetable-based assignment with calculation of the risk of delays was executed and transfers were saved 'between time profiles' in accordance with the general procedure settings. (23144)

PuT Operating Indicators

Two errors occured when calculating indicators for the network object 'Territory PuT detail vehicle journey item': Firstly, the indicators 'Number of service trips' (with and without coupling) were not distributed to the individual vehicle combinations for evaluation levels with vehicle combination. Secondly, values could be output for territories in which the relevant vehicle journey item was not located, if the section for the subsequent vehicle journey item was located in this territory. Both errors have been fixed. (22819)

Ride Sharing

Trip planning and DRT assignment failed if trip requests could not be satisfied: The procedure 'Trip planning' and the timetable-based assignment with use of DRT froze if all trip requests could not be realized, e.g. because no pick-up or drop-off node could be reached in the given walk time or no path could be found from the pick-up to the drop-off node in the network. This error has been fixed. (23048)

Subnetwork Generator

Attribute values at vehicles per block item type were lost: When generating a subnetwork, values of attributes at vehicle units and at vehicle combinations that had subattribute block item type (e.g. cost rate, range, etc.) were lost. This error has been fixed. (23012)

Visum Files

- Crash when importing a version file with line block editor open: Sporadic crashes no longer occur when importing a version file with window recovery when a line block editor is opened at this time. (23130)
- Faulty files result from '&' in codes: In certain cases procedure parameter files and version files could be created that were not readable if the character '&' occurred in strings (e.g. in DSeg code 'P&R'). This error has been fixed. (23019)

New Features and Changes

Add-Ins

◆ Warning when executing add-ins with Python 2: When executing an add-in that uses Python 2, a warning is now issued to remind users that Python 2 support expires. As of PTV Visum 2022, Python 2 is no longer available. (22358)

Installation

• Power saving mode: The PTV Visum application now survives power saving mode, which is common especially on laptops, i.e. if the system is put into power saving mode while the Visum instance is running, the same instance can continue to be used after the system is restored. (22940)

Fixed Bugs

COM-API

Exporting transposed lists to array: No more crash when exporting a transposed list (e.g. list 'PuT assignment statistics' or list 'Emission statistics (HBEFA)') via the SaveToArray method. Transposed lists are also saved to the array in non-transposed form, i.e. the first dimension corresponds to the objects, the second to the attributes per object. (22868)

Data Model

- Copy as user-defined attribute: Copying a given attribute to a user-defined attribute could fail under certain circumstances. This error has been fixed. (22877)
- Restriction of the duration of the calendar period: For very long calendar periods, the number range is not sufficient to display points in time distinctively, with a wide variety of negative effects on the data model and procedures. The duration of the calendar period is therefore now limited to a maximum of 50 years. (22961)

Dialogs

- Crash in parameters dialog of 'Spatial PuT analysis': No more crash when deleting an attribute entry in the parameters dialog of the procedure 'Spatial PuT analysis' if it is the only attribute entry of this procedure. (22926)
- Crash on empty file name for matrix operand from file: A crash no longer occurs when exiting the 'Select the operand for ... ' dialog if loading a matrix from file is selected but no file name is indicated. (22712)
- Indirect attributes not selectable: In some cases, only direct attributes of the network object type could be selected in attribute selection dialogs for numeric attributes, but indirect attributes could not. This bug has been fixed. (22869)
- No context in definition of production and attraction in the 4-step model: In the parameter dialog of the procedure 'Trip generation' of the 4-step demand model, the context could no longer be used in the formula defining the production and attraction. This error has been fixed. (22893)

Filters

Filter on empty multi-enumeration type (e.g. TSysSet) did not always work correctly: If the condition was set in the filter that an attribute of an enumeration type that allows multiple selections (typically sets of objects such as TSysSet, DSegSet, etc.) was not equal to the empty set or contained at least one element of the empty set, network objects whose attribute value was the empty selection fulfilled this filter condition. This bug has been fixed. (22917 ①)

Graphics 3D

Warnings during SBA visualization: If trajectories of an SBA assignment were displayed in the 3D network editor, but were not recorded during the SBA assignment, warnings that occurred during the assignment possibly interrupted the recording of the trajectories. This error has been fixed. (22864)

I/O Interfaces

Crash when exceeding size limit for Access export: A crash no longer occurs when exporting large amounts of data to MS Access when the size limit of 2GB is exceeded. An error message now indicates the limit. Since Access limits the file size itself, the actual problem can only be solved by using other databases, e.g. SQLite. (22649)

Installation

Examples were not installed: The optional examples included with the installation could not be installed. This error has been fixed. (22889)

Lists

Case-sensitive key attribute changes: For network object types whose key is a string (e.g. transport system or line), this key attribute could not be changed in a list if this change consisted only of case-sensitive key changes. This bug has been fixed. (22221)

Network Editor

Crash when removing trivial zigzag routings: Crashes no longer occur when repairing trivial zigzag routings if the coupling would have to be removed for a vehicle journey of the affected line route and the corresponding query was answered with 'No'. (22925)

Other Procedures

Multimodal assignment conceals error messages: If error messages occurred during the execution of the procedure 'Multimodal assignment', the procedure was still considered to have been executed successfully, and as a result, subsequent procedure steps in the procedure sequence were executed. This error has been fixed. (22982)

PrT Assignment

- Crash in SBA in case of missing lane turn: Crashes no longer occur during the execution of the simulation-based dynamic assignment (SBA) if there is an open lane turn with a channelized island in the network for which there is no corresponding lane turn. (22874)
- Rare crash in various assignments: A possible, but very rare cause for crashes in various PrT assignment procedures has been fixed. (22913)
- Warnings during SBA visualization: If trajectories of an SBA assignment were displayed in the 3D network editor, but were not recorded during the SBA assignment, warnings that occurred during the assignment possibly interrupted the recording of the trajectories. This error has been fixed. (22864)

PuT Assignment

Crash in DRT with supplement fares: A crash no longer occurs in a PuT assignment when Demand Responsive Transport (DRT) is used as a supply while using fares that include supplements per transport system. (22895)

PuT Operating Indicators

- Crash on user cancelation: A crash no longer occurs when the user explicitly cancels the procedure 'PuT operating indicators'. (22963)
- Slight errors in line blocks lead to error messages in PuT operating indicators: If the calculation of costs and vehicle requirements in the PuT operating indicators was based on line blocks that contained slight errors (e.g. vehicle errors or layover time errors), this led to the output of an error message in the message window. In this situation, however, the calculation can still be performed, and the PuT operating indicators procedure is then considered to have been completed successfully. This error has been corrected by downgrading the message to a warning. (22980)

Ride Sharing

Crash in DRT with supplement fares: A crash no longer occurs in a PuT assignment when Demand Responsive Transport (DRT) is used as a supply while using fares that include supplements per transport system. (22895)

Safety

Opening version files via double-click: Version files with the 'Safety' tool window visible in their window configuration could not be opened by double-clicking the version file. This error has been fixed. (22837)

Breaking Changes

Filters

Filter on empty multi-enumeration type (e.g. TSysSet) did not always work correctly: If the condition was set in the filter that an attribute of an enumeration type that allows multiple selections (typically sets of objects such as TSysSet, DSegSet, etc.) was not equal to the empty set or contained at least one element of the empty set, network objects whose attribute value was the empty selection fulfilled this filter condition. This bug has been fixed. Thus, procedures that are restricted to 'Active network objects only' deliver different results than before. (22917 🔊)

New Features and Changes

I/O Interfaces

Export to PTV Visum Publisher: Data can now be exported to the web publishing product PTV Visum Publisher.
 (22359)

Fixed Bugs

COM-API

- Closing Visum after GPX import: A Visum instance started via COM could not be terminated after a GPX import, i.e. the application was not terminated when the Visum COM object was released. This error has been fixed. (20673)
- Closing Visum after VDV452 import: A Visum instance started via COM could not be terminated after a VDV452 import with the 'ImportBlocks' option activated, i.e. the application was not terminated when the Visum COM object was released. This error has been fixed. (22792)
- Sporadic crashes when setting obsolete attributes: In order to avoid code adaptations as much as possible when porting script code from one Visum main version to another, it is possible to set the values of obsolete attributes, i.e. those that no longer exist in the Visum data model, with the information then being passed internally to the new location in the data model. However, setting such obsolete attributes could lead to sporadic, i.e. non-reproducible crashes in certain cases. This bug has been fixed. (22599)

Filters

Multiple calculation of volume attribute filter in version comparison: If a version file contained a version comparison with a network loaded in the background and the volume attribute filter with the option 'Filter according to active vehicle journey sections or time profiles' was active in both networks, then, under certain circumstances, the evaluation of the volume attribute filter was executed too often. This error has been fixed. (22411)

Graphics

Wrong legend for percentages: Attributes containing percentages were displayed incorrect in the legend. This bug has been fixed. (22714)

I/O Interfaces

- Shapefile import more tolerant: Previously, the import of a shapefile in which an object had an empty course would be canceled. The behavior is now more tolerant, assuming a trivial course (coordinates 0, 0). In this case the attributes of the object are now transferred. (22773)
- Vehicle journey not imported due to invalid vehicle journey section during railML import: If the railML import contained operating points ('ocp') that were not allocated and individual 'trainPart' elements were therefore shortened to only one operating point, vehicle journeys whose 'train' was composed of more than just this one 'trainPart', so that a valid route course was still created, were not imported. This error has been fixed. (22738)

Lists

Copying lists to user-defined tables: If a list contained a column for an attribute of type duration or time, which was displayed without units but in minutes or hours, then the values of this column were taken as seconds when copying the data to a user-defined table. This error has been fixed. (21801)

Main Window

Change of tab when activating a detached window group: If two windows (network editor, start page, lists,...) in a common tab group were detached from the main window of the application and you clicked the title bar of this group to set the focus on this group, sometimes the tab of this group displayed in the foreground changed with this click. This bug has been fixed. (22549)

Matrix Estimation

Subnormal results using 'Least squares' method: When using one of the two 'Least squares' variants of the 'Demand matrix correction' procedure, subnormal numbers could occur in the corrected matrix, i.e. numbers that are so small that they cannot be represented in the normal number range. This error has been fixed. (22823)

Miscellaneous

Links to documentation of usage data: Some of the links on the 'Usage data' page in the 'User preferences' dialog that provide information about how usage data is used no longer worked. This bug has been fixed. (22689)

Network Comparisons

Multiple calculation of volume attribute filter in version comparison: If a version file contained a version comparison with a network loaded in the background and the volume attribute filter with the option 'Filter according to active vehicle journey sections or time profiles' was active in both networks, then, under certain circumstances, the evaluation of the volume attribute filter was executed too often. This error has been fixed. (22411)

PrT Assignment

Reading in user-defined VD functions when double-clicking: When opening a version file by double-clicking in Windows Explorer, associated (i.e. located in the specified directory) user-defined VD functions were not loaded. This error has been fixed. (22499)

PuT Operating Indicators

- Departures, arrivals, service trips at stop points/stops as well as stop events, start stop events at territory PuT detail for shortened vehicle journeys: If a vehicle journey did not start at the first time profile item on a calendar day of the analysis period, then these indicators were calculated incorrectly. This error has been fixed. (22756)
- Incorrect calculation of dwell time at the end of shortened vehicle journeys: If the last vehicle journey item of a shortened vehicle journey (i.e., which does not cover the full length of the time profile) coincided with the change of day between two calendar days in the AP or with the change from one analysis time interval to the next, the dwell time at this vehicle journey item was calculated incorrectly. This error has been fixed. (22857)
- Incorrect dwell time at day change for vehicle journeys with holes: If a vehicle journey had a 'hole' on a calendar day because no vehicle journey section covered a section in the middle of the vehicle journey on that day, but there were vehicle journey sections before and after, and the last vehicle journey item before the hole was the last one on a day or analysis time interval, then the time between the start of the stop and the end of the day or time interval was used as the dwell time. This error has been fixed. (22876)
- Incorrect specific passenger trips per transfer for circle lines: In the case of circle lines, the values of passenger trips per number of transfers were reported too high. This error has been fixed. The general passenger trips, i.e. not differentiated according to the number of transfers, were not affected. (22791)
- Passenger trip chains had no effect on the number of service trips (uncoupled): Passenger trip chains were previously not taken into account when calculating the indicator 'Number of service trips uncoupled' at stops and stop points. This error has been fixed. (22835)

Safety

- Generating sections faulty: The automatic generation of sections has been improved in that different sections with the same end nodes are now only merged if they have the same aggregation rank. (21056)
- Handling of user-defined attributes: When opening a version file that has been previously prepared for use with Visum Safety, various error messages occurred regarding the existence of user-defined 'SAFETY_' attributes. This error has been fixed. (21715)
- Infinite loop when generating sections: The generation of sections could lead to an infinite loop in rare cases. This bug has been fixed. (21025)

Visum Files

Crash when reading attribute files for links with shortest path seraches: No more crash when reading attribute files for links if in the extended options the shortest path search is activated in case of links that are not found in the target network. (22856)

I/O Interfaces

- Creating stop points in PuT Updater: If the import of a public transport supply from Visum ('PuT Updater') does not allow the insertion of nodes and links in the target network, a new parameter can now be used to control whether stop points for which there is no candidate in the target network within the snap radius are nevertheless inserted (with nodes and links) or whether their stop is omitted. (22641)
- Handling of files without format specification during HAFAS import: If there is at least one file without an explicit format line during an import of HAFAS raw data or the unclear character format 'Character encoding according to general transform parameters' is selected, the user is prompted whether the files should be interpreted as UTF-8 or ANSI. This can also be used to fix problems with allegedly invalid file formats if they are caused by the incorrect counting of the character position. However, it is still not possible to read in data sets with different character encoding for each file. (22639)

Installation

The CodeMeter Runtime deployed with PTV Visum has been updated to CodeMeter 7.21a. (22750)

Fixed Bugs

Activity Profile

Reference objects not in version file: In the case of activity profiles as well as the line route editor, the selected reference objects were not saved in the version file. This may have resulted in a different view when saving and later restoring. This error has been fixed. (22682)

Add-Ins

Coding problem in 'Import TransCAD Network': In certain cases, there were character coding problems when running the 'Import TransCAD Network' add-in. This error has been fixed. (22730)

COM-API

COM calls possible with open dialog: An incoming COM call was no longer reliably rejected if a modal dialog was open at the same time. This bug has been fixed. (22595)

Demand Procedures

Crash in case of Nested Demand with demand at a higher level: A crash no longer occurs when executing the procedure 'Nested Demand' if only the mode choice is calculated and saving demand at the mode choice level is activated. (22505)

Dialogs

Crash when switching off bars: A crash no longer occurs when switching off bars in the graphic parameters dialog if the calculation of the minimum and maximum values of the corresponding attribute in the network has not yet been completed at this point. (22607)

Graphics

Scale limit for 'Draw until scale' incorrect for large scales: If the 'Draw until scale' option was selected in the graphics parameters for a network object or a class of network objects with one of the two largest scales ("1:5000000 (continental map)" or "1:10000000 (world map)"), objects were not drawn according to the set scale limit, but only for significantly smaller scales. This bug has been fixed. (22447)

I/O Interfaces

- Double coordinate transformation of the From- and To-nodes of links: If a coordinate transformation was used during the shapefile import of links and the nodes did not already exist in the network, then their coordinates, which in this case result from the first and last point of the polyline of the link, were transformed twice. This error has been fixed. (22666)
- Shapefile export of linear POIs did not work: The shapefile export of linear POIs, i.e. POIs whose surface is a polyline, always resulted in an empty shapefile. This error has been fixed. (22749)

Lists

- Crash of PuT OD pairs list when selecting a new DSeg: A crash no longer occurs when selecting a demand segment in the PuT OD pairs list if this new demand segment is newly created in the same session and then assigned together with an already existing one. (22643)
- No synchronization of the path items list: In the 'Path items' list, synchronization in reverse direction did not work, i.e. a path item in the global marking was not highlighted in the list. This bug has been fixed. (20979)
- Origin zone filter for paths and path items lists: For the 'Paths' and 'Path items' lists (i.e. for the user-defined paths, not for paths from PrT assignments), the origin zone filter was neither saved in the list layout file nor in the version file. This error has been fixed. (17672)

Network Editor

Crash after creating main nodes: Crashes no longer occur when creating multiple main nodes that do not have main turns (e.g. because there are no partial nodes or no cordon links). (22554)

PrT Assignment

- ✓ Inconsistent value ranges for stochastic assignment parameters: For some parameters of the stochastic assignment, the checking of the value range in the procedure parameters dialog and when reading from files (version file, procedure parameters file) was inconsistent. This error has been fixed. At the same time, the permitted value range of some parameters has been extended. (22674)
- Split optimization for very small volumes: Split optimization of external signal controls did not work in the case of very small turn volumes. This error has been fixed. (22727 ①)

PuT Operating Indicators

- Departures, arrivals, and service trips at stop point and stop: For vehicle journeys with spatially and temporally overlapping vehicle journey sections, the same stop event was counted more than once for the indicators 'Number of service trips uncoupled', 'Number of PuT departures' and 'Number of PuT arrivals' at stop points and stops. This error has been fixed. (22744)
- Incorrect value for 'Number of service trips uncoupled': The calculation of the indicator 'Number of service trips uncoupled' at stops and stop points was incorrect for time intervals. This error has been fixed. (22739)
- Unstable results: When run repeatedly on the same data, the 'PuT operating indicators' procedure produced slightly different results for some demand-related indicators when there were multiple assigned demand segments. This error has been fixed. (22259)

Attribute description truncated in attribute selection: Longer texts of attribute descriptions were truncated in the attribute selection dialog. This bug has been fixed. (22202)

Filters

Selections in the filter grow when network changes: In group filters (e.g. line filters) there is a selection of objects per network object type. When network objects of the corresponding type were created, they were always included in this selection of the filter, even if the selection itself was not active as a filter condition. Especially in the case of mass insertions, as they happen for example when aggregating line routes, the size of filter files and consequently also of version files increased massively. Safety

No message when executing 'Accident time series analysis' without previous APM: If the add-in 'Accident time series analysis' was executed without an Accident Prediction Model being calculated in the same network beforehand, no useful error message was displayed until now. Data Model

Licensing of the mode attribute 'Interchangeable': The attribute 'Interchangeable' of the mode is used within the tourbased demand model, but was previously not activated for the add-on Tour-based demand model. This error has been fixed. (22230)

Dialogs

- Combination of DRT and Fail to board: In the dialog of the timetable-based PuT assignment, it was previously possible to combine Fail to board with the use of DRT systems, but the procedure could not be executed in this combination. The dialog now prevents this combination, and if procedure parameters are displayed in which this combination is already set, a warning is issued in the dialog and the setting is changed. (22100)
- Incorrect position when inserting procedure parameters: If a specific position is selected when reading procedure parameters additively and then 'Start of the process sequence' is selected again, the procedure steps have nevertheless been inserted at the position selected first. This error has been fixed. (22219)

Formulas

Formula attributes with subattribute and placeholders: If a formula attribute with subattribute AHPI (this is the only allowed subattribute dimension) is defined by a formula in which another attribute with subattribute API or AI is used through placeholders, the definition for the subattribute values AH or for AH and AP is 'missing'. This caused various problems and messages. This bug has been fixed in that such a formula is now defined by definition for AH (and AP) as well, where the value for these subattribute values is always the empty value. (21995)

Infinite loop when updating formula matrices with warnings: If warnings occurred when updating multiple formula matrices, for example, because a demand segment of the specified code no longer existed, an infinite loop could occur, causing the user interface to stop responding. This bug has been fixed. (22270)

Graphical Procedures

Crash when frequently calculating PrT flow bundles: No more crash when calculating PrT flow bundles numerous times (> 300) within the same session. (22166)

Graphics

Cross-section values for transfer relations: When displaying transfer relations in the network editor, the value of one of the two directions was displayed instead of the sum when using the 'Use cross-section values' option. This error has been fixed. (22234)

I/O Interfaces

- Invalid line routes when using the import 'PuT supply from Visum': Using the import 'PuT supply from Visum' invalid line routes can arise when inserting stop points on links is allowed during the import in the target network and then in the context of editing a line route such a stop point is inserted on the link which is already crossed by a routed part of the same line route. This error has been fixed. (21926)
- Suppress error messages during Emme import: During the Emme import, messages about lines that could not be read could not be suppressed, but had to be confirmed individually. This error has been fixed. (22199)

Installation

Note to CodeMeter manual: For licensing errors PTV Visum refers to the CodeMeter manual. So far, however, the reference has been made to an CodeMeter overview document instead of the manual itself. This error has been fixed. (22249)

Matrix Estimation

Dialogs with relative paths: In the parameter dialog of the procedure 'Demand matrix correction' a direct entry of the file name for the result or flow matrix has not been accepted when exiting the matrix selection dialog. Consequently, it was impossible to specify a relative path for the file. This error has been fixed. (22143)

Network Editor

Lost access nodes when simplifying node-link network for public transport: When executing the multi-edit special function 'Simplify node-link network for public transport' access nodes of stop areas got lost. This error has been fixed. (22154)

Other Procedures

Incomprehensible error message when optimizing the signal offset without relevant conditions: If there are no relevant relations between the different signal groups of signal controls to be optimized, for example, because the volume is too small or the distance is so large that it can be assumed that the platoon is dissolved, then there are no relevant conditions for the optimization of the signal offset time. The execution of the procedure 'Signal offset optimization' provided an insufficient error message in this case. It has been improved so that the case can now be identified. (21968)

PrT Assignment

☑ UDA to control lane choice in SBA: A network UDA (ID 'SBAUseLaneChoiceLookaheadForPockets') of type Bool can be used to control lane choice on approaches with pockets and separated right turns. If this attribute is 'true', vehicles entering the link will choose lanes that allow them to turn at the To-node of the link according to their route. If this attribute is 'false', the behavior corresponds to the current default, i.e. the lane choice only takes into account the turning possibilities at the following node. In particular, this also includes internally generated nodes, e.g. at the beginning of a pocket. If there are several pockets and/or separate right turns, unrealistic lane changes may occur. The behavior for 'true' changes the results of the SBA assignment and corresponds to the behavior that applies in PTV Visum 2022. (21780)

Procedure Sequence

Crash when executing the procedure sequence while editing an input field: No more crash when executing the procedure sequence and an input field (e.g. file name) has not been properly quitted after editing. (22024)

PuT Assignment

Crash when calculating a skim matrix for stop areas with a formula matrix as demand: No more crash when executing the procedure 'Calculate stop area skim matrix' if the demand of the selected demand segment is defined by a formula matrix. (22134)

Ride Sharing

Import from MaaS Modeller with different target attributes failed: The import from MaaS Modeller failed if attributes with different names were selected for the induced volumes of links, turns and main turns from PrT paths of ride sharing vehicles. This error has been fixed. (22204)

Visum Files

- Crash when reading old model transfer files with deleted nodes that are used in paths: No more crash when reading model transfer files saved with PTV Visum 2020 or earlier versions which contain deleted nodes that are part of PrT paths. (22194)
- Warning when reading attribute files that cannot be read: Certain attribute files cannot be read. When saving such files a corresponding hint is given. However, when reading such files the error message was not clear. This error has been fixed. The message now states that tables of the type found in the file cannot be read. (21950)

Breaking Changes

COM-API

Accelerating the aggregation of line routes; The aggregation of line routes via COM has been accelerated. As a
result the naming of the resulting network objects changes. The interactive aggregation of line routes is not affected.

- Incorrect adjustment of the origin lane when changing the number of lanes of a link: If a link had several outer pockets at a node, the origin lane for the pockets was not correctly adjusted when increasing the number of lanes of this link, so that a pocket came to be located between the through lanes, which is a forbidden constellation. This error has been fixed. (22046)
- Planned connecting journeys crash: No more crash when displaying planned connecting journeys (e.g. in the list) if the network was previously changed in such a way that the line route items still existed at the respective alighting and boarding point of the planned connecting journey, but there was no longer a stop at a stop point at this location. Dialogs

- Crash when creating a zone time series: A crash no longer occurs when creating a time series for a new zone type relation while editing a demand time series. (22148)

Calculation of dynamic aggregation too slow: The calculation of dynamic aggregation in the matrix editor was unnecessarily slow and has been accelerated significantly. (21783)

Network Editor

Crash when moving a stop point: A crash no longer occurs when moving a stop point from one link to another. (22090)

PrT Assignment

- Assignment with 0 iterations no longer possible: The (classical) equilibrium assignment could no longer be used to adjust the route volumes to a changed demand by using the existing solution as initial solution and the value 0 as number of iterations, because it was no longer possible to enter the latter in the dialog. This bug has been fixed. (22137)
- Assignment with ICA: A crash could occur, if there existed node legs that were ignored in the ICA calculations. This specifically happens, if there are PuT node legs. The crash occured on signalized nodes with the analysis method HCM, 6th Edition. This error was fixed. (22155)

Models created with previous service packs of PTV Visum 20 or PTV Visum 21 do not work as before if skim matrices are newly created but matrices with a capitalized transport system code are expected in matrix references. Fixed Bugs

COM-API

Problems creating Python cache files in Python 3: In Python 3, sometimes a Python cache file could not be loaded. This error has been fixed. However, since the bug is contained in Python (more precisely in the pywin32 package), it cannot be fixed by installing a Visum update. Data Model

Automatic link orientations incorrect: When resetting the calculation method for orientations at the node to automatic, the original orientations were not always restored. This error has been fixed. (21838)

Demand Procedures

Non-deterministic results in tour-based model: The procedure 'Tour-based model - Combined trip distribution / mode choice' could produce unstable mode choice matrices under certain circumstances, i.e. the results differed slightly for runs with identical input data. This error has been fixed. (21474)

Dialogs

- Creating an alias in attribute selection inserts attribute: If an alias was created in the attribute selection of an attribute list and the dialog for creating the alias was closed with the Enter key, then not only the alias was created, but the attribute was also included in the attribute selection. This error has been fixed. (21954)
- Infinite loop in the line route editor: In the line route editor, entries made in one of the cells displayed offset (e.g. Runtime) could result in an infinite loop. This error has been fixed. (21974)

Filters

No filtering on identifier attributes: For technical reasons, the identifier attributes operator identifier at the vehicle journey and valid day identifier and vehicle combination identifier at the vehicle journey section cannot be used properly in filter conditions - a condition with these attributes is never true. Crash when duplicating formula attributes: PTV Visum longer crashes when duplicating a user-defined formula attribute via the 'Duplicate attribute' shortcut menu action in any list. (21939)

Ride Sharing

- Crash in tour planning procedure with reoptimization: Fixed crash in tour planning with reoptimization in certain cases. (21969 0)
- Distribution of pre-booking time: The generation of pre-booking times based on the given distribution is now independent of the random seed of the trip request generation. (22000 •)
- Tour planning with re-optimization stops: In certain constellations, the 'Tour planning' procedure stopped if re-optimization was activated, i.e. the procedure did not finish, but could still be canceled. This error has been fixed. (21983)

Scenario Management

Crash in scenarios with modifications that are mutually exclusive: If there were two mutually exclusive modifications in a scenario management project, a crash used to occur when defining a scenario as soon as both mutually exclusive modifications were selected. This error has been fixed. (21998)

Signal time-space diagram

Permanent green not visible with time offset: For a permanent green signal group, no bars were displayed in the signal time-space diagram if the offset was not equal to 0s. This error has been fixed. For permanent green signal groups, a small separator is now also displayed to visually indicate the offset and to help to understand the time course of the vehicle platoon. (21966)

Timetable Editor

Timetable does not update when filter for volume attributes is changed: If the filter for volume attributes (formerly the OD pair filter with the option 'Filter network volumes') was changed or activated, the graphical timetable was not redrawn with the reduced volumes as bars. This error has been fixed. (20990)

Visum Files

- Additive reading of user-defined attributes and time interval sets: If time interval sets and user-defined attributes were read additively from a network file in the same process and an offset was used for the time interval sets to avoid conflicts, this offset was not considered when using this time interval set as subattribute for an imported user-defined attribute. This error has been fixed. (21992)
- Crash when canceling 'Read network file': A crash no longer occurs when canceling the non-additive reading of any network file. (21912)
- Crash when saving to insufficient storage space: Visum no longer crashes when saving a version file to a medium with insufficient space. (22001)
- Display area of the network editor moved: If the display area of the network editor was moved without having the focus (e.g. by synchronizing with moving the view), and then a version file was saved, an incorrect view of the network editor was created when restoring the display area. This bug was fixed. (21987)

Breaking Changes

PrT Assignment

● Evaluation of the VD function BPR3 for network objects without travel time t0: The calculation of the VD function BPR3 at network objects (i.e. links, nodes, main nodes, turns, or main turns), on which the travel time in the unloaded network t0 had the value 0s, was faulty within some PrT assignment procedures. Data Model

Weight instead of share in the HBEFA data model: In the data model, the terminology has been improved in the context of emission calculation according to HBEFA. In particular, attributes that actually indicate weights, because they do not have to add up to 1 in the sum of all objects, have been named accordingly. Correspondingly, the terms 'share' and 'weight' are used more precisely in the user interface. (21824)

- Crash after renaming POI categories or table definitions: Crashes no longer occur after renumbering POI categories or renaming table definitions. (21899)
- Empty values when converting strings to numbers: When changing the data type of a user-defined attribute from a string (text or file name) to a numerical value, empty strings were interpreted as empty values and an incomprehensible warning was issued if the user-defined attribute did not allow empty values. The default numerical attribute value is now set in this case. (21875)

Dialogs

Performance problems in case of many formulas: In networks with a lot of formula attributes and formula matrices, various performance problems occurred, for example when reading the version file, changing attribute values, or applying model transfer files or modifications in scenario management projects. This error has been corrected. (21475)

Graphics

Highlighting remained visible: If the mouse pointer left the drawing area of the legend in a graphic window with a legend (network editor, graphic timetable, schematic line diagram, or transfers display of regular services), the highlighting drawn in the area of the mouse pointer continued to be there. This error has been fixed. (21930)

Junction Editor

Crash when changing signal control data: The program no longer crashes when making certain changes to the signal program of external signal controls (Vissig), for example changing the signal state sequence of a signal group. (21970)

Main Window

- Crash when loading a global layout file in the procedure sequence: A crash no longer occurs when reading a global layout file in a script that is executed in the procedure sequence. (21941)

Fast InProcess matrix data transfer after internal script no longer possible: If a script was executed as part of a procedure step 'Run script', whose code was stored directly in the procedure parameters (i.e. without reference to an external script file), the fast direct data transfer between PTV Visum and Python via the methods VisumPy.helpers.GetMatrixRaw / SetMatrixRaw no longer worked. - Crash in case of grouped PrT path list on link level with link filter: Visum no longer crashes when changing the link filter when a grouped PrT path list on link level is displayed with the 'Only active links' option. (21693)
- Group column and column filter: In rare cases, the elements displayed did not match the grouping or column filter criteria entered by the user. This error has been fixed. (21649)
- Marking a lot of ABM objects: The program no longer freezes when marking a lot of activity locations in the list. (21655)

Main Window

Vehicle journey sections with operating periods incorrect: The multi-edit special function 'Normalize vehicle journey sections' yielded an incorrect result if the corresponding vehicle journey sections had operating periods associated.
